Whether it was the promised delights from Wings Guru, the new and useful tool for housing development, or the chance to be photographed with the "puzzle sign", folks filled the Elvis Presley location June 30 for the West TN Council meeting.

Council Chair Trey McKnight welcomed the guests. Coalition Executive Director Patricia M. Smith emphasized the importance of the Coalition, referencing the presentation of a \$65 million fund for starter homes in the Governor's

budget being ignored this spring and not funded by the members of the General Assembly.

"Knock, knock, knock," said Smith. "Your members need to know you, know your constituents, know the successes you have delivered. Data is available from Convergence Memphis, MTSU, THDA, your own experiences. Elected officials need to know who you are and what you can provide for the economic security for persons and for the community."

Jaynes Joins Tennessee USDA

On June 2, 2025, Patrick Jaynes was sworn in as the new USDA Rural Development Tennessee State Director. Mr. Jaynes brings a wealth of experience to USDA Rural Development in his new post. He most recently worked as Senior Consultant for Nashville, TN based, Jigsaw Consulting where he engaged in local, state, and federal government relations, as well as high-level communication and strategic business consulting.

Prior to his work with Jigsaw, Mr. Jaynes served for 18 years as Deputy Chief of Staff and State Director with U.S. Senator Lamar Alexander. He managed the staffing and operation of six statewide Tennessee offices which provided constituent services, fieldwork, and state scheduling.

An interesting fact about Mr. Jaynes is that before the U.S. Senate, he worked as Public Relations Director and Sponsor Marketing with the International Hot Rod Association Championship Drag Racing. He also assists with his family farm in East Tennessee which produces cattle, hay and soybeans. He is a graduate of Tusculum University and lives outside Knoxville, TN with his wife, Jill.

He will be traveling across Tennessee through the remainder of 2025 to meet partners and customers and to share the administration's priorities for affordable housing.

Through the Coalition, members can know others throughout the industry, she continued.

REALTORS®, builders, lenders, counselors, developers, planners, government employees, all the people involved in serving people who need housing can follow the goals of the Coalition: Connect, Educate and Advocate.

"We'll find the issues we can work on together and make the effort to communicate through our communities and to our elected officials."

Each of the three Regional
Councils invited Matt Wiltshire of
Pathway Lending to present on the
possibilities and history of PC
1012, passed by the TN General
Assembly in 2024. Wiltshire learned of
the municipal-supported bond concept
when he visited Charlotte, North
Carolina with the Nashville Area
Chamber of Commerce. He has a
particular interest in preserving existing
housing.

"A developer buys a property, paints it, landscapes it, and raises the rents," he said. With the bonds issued by the local Industrial Development Board, credit support can be offered so improvements can be made without requiring higher rents to cover market costs of borrowing.

Charlotte has had great success. Voters

have approved 11 bonds totaling \$260 million since 2002. Their Housing Trust Fund has been used to support a variety of affordable housing needs including creation and preservation: $\cdot 0\%$ to 1% interest-only loans to support preservation

- City-support for LIHTC-funded projects
- Land acquisition
- Homeownership funds
- Housing within Transit-oriented development districts

Wiltshire's comments generated a question immediately about whom to contact locally. Memphis city officials were in the audience, fully alert to the interest sparked.

Enterprise Community Partners Sets Rural Housing Meet

August 6-7 Hyatt Place, Knoxville, Downtown

Enterprise Community Partners is hosting two-days of conversation about rural affordable housing preservation and development in Knoxville, TN. This in-person convening is an extension of the Rural Rental Preservation Academy and will focus on policies, funding, and innovative strategies to address rural affordability at the federal, state and local levels.

Day One: USDA 515 Portfolio - 8-4:30 p.m.

Presentations on successful approaches to preservation in rural communities with a particular focus on the preservation of USDA 515. There will be a focus on layering new financing into preservation projects and national policy efforts to support the preservation of the USDA housing portfolio.

Day Two: Advancing Rural Housing in Appalachia — Policy, Research & Innovation - 8-1 p.m.

Attendees will focus on policy, research and programs in the Appalachian region that support affordable housing development and preservation in rural communities. <u>Celebrating Extra Effort</u> Tennessee's Best Enjoy Deserved Spotlight



The phrase "numbers numb, stories move" drives marketing firms. You can see it in broadcast and print advertising: "If you use this, you'll feel like this." We're human and we want to connect to other humans.

As the Coalition learns to tell its members' stories, let's celebrate those who were applauded at the THDA Housing Conference this year in the TN's Best review.

The **East TN** honoree was The Caring Place. The Cleveland-based non-profit has used effectively several programs: the Emergency Solutions Grant, HOME ARP Supportive Services and Eviction Prevention.

Through its Opportunity Center, The Caring Place provides individualized, client-led case management with the goal of assisting neighbors in increasing stability. The Access Home program is the primary program through which funds from THDA are leveraged to prevent evictions and assist people in moving into stable housing. The Caring Place also partners with United Way for he Housing United program, which provides Rapid Rehousing to individuals and families experiencing homelessness. In addition, the

In addition, neighbors often dual-enroll in the Getting Ahead program for additional support. This program is focused on exploring poverty in a supportive group format in order to build resources to "get ahead." In 2024, 251 households received financial assistance to obtain or maintain their housing.

From the **Middle Tennessee** grand division, a uniquely creative partnership between a developer and nonprofit recovery effort resulted in what is now known as Shelby House.

The master plan development of Shelby House and Samaritan Recovery Community (SRC) reimagined the 4-acre site where SRC has provided services for over 50 years. As part of the redevelopment, the site has been thoughtfully divided into three distinct properties: SRC's new 70,000 sq. ft. facility, Shelby House Apartments, and 4th & Shelby. The new facility increases SRC's capacity from 50 to 132 beds, creating a more robust support system for those in recovery. Additionally, the two apartment communities provide a new income stream for SRC to continue providing life-changing services and a path to housing for SRC graduates.

For a combined 484 affordable units in the heart of East Nashville, phase 1, Shelby House, features 195 affordable units, and phase 2, 4th & Shelby, includes 289 affordable units ranging from 30-80% AMI.

The Joint Center for Housing Studies released its annual "The State of the Nation's Housing 2025" report.

The release statement follows: The US housing market is shrouded in uncertainty. High home prices and interest rates have pushed sales to their

Throughout this report, the theme of market normalization and gentle correction recurs in our analysis as East Tennessee moves past the disruptive events of the pandemic and subsequent effects on housing. Despite many headwinds challenging affordability and slowing sales, East Tennessee's housing market is poised for growth and recovery. ... challenges linger ... resilience and stability ... dedicated to supporting that vibrancy through education and advocacy for smart growth policies. The market currently stands at a promising tipping point. If advocates, neighbors, elected officials, policymakers and community leaders can work together to reduce barriers and increase housing supply and diversity, the region could reach a healthy balance ... in as little as five to ten years.

lowest level in 30 years; insurance premiums and property taxes are on the rise; high rents have left record numbers with cost burdens; and devastating wildfires have highlighted the growing dangers of climate disasters. And the increasing likelihood of an economic downturn threatens to deepen these challenges. The report is available on the Center's site: The State of the Nation's Housing 2025 | Joint Center for Housing Studies. A video of the release included a twohour presentation including some innovative ideas such as eliminating forced broker's fees for a rental unit (Massachusetts) and payments in lieu of a security deposit (49:43). Tenant pays instead, monthly premiums on an insurance policy to the benefit of the landlord. The homebuilders association offered its comments: Harvard Report Shows the Housing Affordability Crisis Worsening NAHB.

NAHRO (National Association of Housing and Redevelopment Officials) offers an indepth study of the report in its July edition of the NAHRO Monitor.
